INFORMATION FOR THE MARKER

In assessing a learner's work, the following aspects, among others, drawn from the assessment rubric, must be borne in mind:

- The overall effect of planning, drafting, proof-reading and editing of the work on the final text produced.
- Awareness of writing for a specific purpose, audience and context – as well as register, style and tone – especially in SECTION B.
- Grammar, spelling and punctuation.
- Language structures, including an awareness of critical language.
- Choice of words and idiomatic language.
- Sentence construction.
- Paragraphing.
- Interpretation of the topic that will be reflected in the overall content: the introduction, the development of ideas and the conclusion.

- Various formats of transactional/referential/informational texts have been taught/are in current practice. This has to be considered when assessing the format.
- Give credit for appropriateness of format.
- Look for a logical approach in all writing.

NOTE:

- The points given below each topic in this memorandum serve only as a guide to markers.
- Allowance must be made for a learner’s own interpretation of the topic, even if it differs from the given points or a marker’s own views or interpretations.



SECTION A: ESSAY**QUESTION 1**

Learners are required to write ONE essay of 250 – 300 words on ONE of the given topics. Learners may write in any genre: narrative, descriptive, reflective, argumentative, expository, discursive or a combination of any of these.

- 1.1 Reflective essay on the role music plays in the learner's life. Learners must write about the role music plays in THEIR lives, not teenagers in general. [40]
- 1.2 Narrative essay – the topic sentence can be used at any point in the essay. [40]
- 1.3 **NOTE:** There must be a clear link between the essay and the picture chosen.
- 1.3.1 **Group of teenagers using technology**
Teenage life, social media, young people and technology, friends, etc. [40]
- 1.3.2 **Abandoned/deserted house**
Possible narrative or descriptive topic, why was the house abandoned, ghost story, coming across this house and entering it, etc. [40]

SECTION B: LONGER TRANSACTIONAL TEXTS

QUESTION 2

Learners are required to respond to ONE of the topics set. The body of the response must be 160–180 words in length. The language, register, style and tone must be appropriate to the context.

2.1 Friendly/informal letter

Friendly/informal letter format and date. Letter is addressed to a teacher who had a positive influence on the learner. Focus should be on thanking the teacher (letter of appreciation/thanks).

2.2 Minutes of a meeting

Date, time, and venue where the meeting took place. Learners should use the following headings: Opening/Welcome, Present/Apologies, Minutes of Previous Meeting, Matters Arising, Business Matters, Date of next meeting and Closure.

2.3 Dialogue

A valid dialogue format must be used (no inverted commas, line left open between each speaker, speakers' names on the left followed by a colon).

2.4 Letter of application / covering letter

Formal letter format, date, subject line, letter should end with, 'Yours faithfully'. Letter should attempt to persuade the employer to invite them for an interview. This letter would be sent together with the learner's CV.
