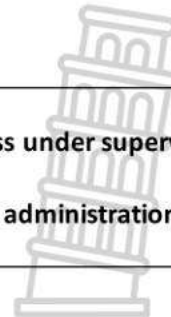

- 9 The owner took R 1 200 cash for personal use.
- 15 The bank statement shows:
  - a stop order for Insurance of property, from Vuka Insurers for R 2 500,
  - paid wages for R 4 500 via EFT
- 20 Received R 3 500 for services rendered to customers as per Cash register roll
- 21 Paid Telkom for Telephone via EFT R700
- 30 Equipment was purchased from Hair Network paid via EFT for R 21 000
